*Each candidate will be required to obtain a minimum score (cut-off) in each section of Preliminary (online) test as well as a minimum score (cut-Off) in the total score of 75 for participation in further selection process (Mains Examination). Adequate number of candidates, depending upon requirements, will be shortlisted for Main Examination. However, the Bank reserves the right to change the minimum/ waive off qualifying criteria at its sole discretion.*

*There will be penalty for wrong answers in all the sections. For each question for which a wrong answer has been given by the candidate, 0.25 of the marks assigned to that question will be deducted as penalty to arrive at corrected score. If a question is left blank, i.e. no answer is given by the candidate; there will be no penalty for that question.*

**On-line Pre-Examination Training:**
